## **MINUTES**

- 1. Julie Robinson, Chairperson of the External Relations Committee, convened the meeting at 1:27 p.m. in Room 1108B of the College Welcome Center.
- 2. Recommended approval of the Minutes of the November 8, 2018 meeting.
- 3. Dr. Michael Chipps reported that Senator-elect Tim Gragert visited campus this past month and was very appreciative to tour campus and receive information regarding Northeast Community College. Mr. Gragert indicated that when canvasing for the election, numerous concerns were voiced regarding community college property taxes and he wished he would have had the facts while canvasing. Dr. Chipps indicated that Northeast Community College needs to take a stronger position in making sure that senators are provided the opportunity to understand community colleges in greater detail.
- 4. In other business, Dr. Chipps and Steve Anderson reported that the Community College National Legislative Summit (NLS) is the premier event sponsored by the national organization, the American Association of Community Colleges (ACCT). NLS provides the opportunity to go to Washington, DC to meet with legislators and obtain an understanding of what the topics are at the national level. National legislators also appreciate the opportunity to meet with board members and learn about issues at community colleges that need to be addressed.

Also in other business, Mr. Anderson stated that at the NCCA Annual Meeting in November, the discussion that took place regarding the College Promise was to bring the information to the forefront and let board members determine if this should move forward. Mr. Adams' work on the College Promise will accelerate following adjournment of the legislative session. Mr. Adams will look for several models of the College Promise and bring that information forward for consideration.
