## **MINUTES**

- 1. The meeting was convened at 11:43 a.m. in Room 1108B of the College Welcome Center by Arlan Kuehn, member of the Facilities Committee.
- 2. Recommended approval of the Minutes of the November 9, 2017 meeting.
- 3. Lynne Koski reported that Northeast Community College was approached by the City of South Sioux City for an easement to correct some drainage issues. The new drainage system runs across Northeast's property. Wayne State College's board will also need to approve an easement.
  - Following discussion, a consensus was reached by the Facilities Committee to recommend approval of the Easement to the City of South Sioux City, Nebraska to construct an underground storm sewer pipeline.
- 5. In other business, Dr. Chipps reported that in the last 30-45 days a lot of progress has been made in West Point with the acquisition of the property and site preparation.
