- 1. Keith E. Harvey, Chairperson of the Governance Committee, convened the meeting at 2:17 p.m. in Room 1108B of the College Welcome Center.
- 2. Recommended approval of the Minutes of the July 13, 2017 meeting as distributed.
- 3. Craig Garrett presented revisions to BP-3060, <u>Recognition Policy</u>, reporting that the only change is the reference of the administrative procedure in the trailer of the document.
 - A consensus was reached by the Governance Committee to accept the FIRST READING of revisions to BP-3060, Recognition Policy.
- 4. BP-3233, <u>Alcoholic Beverages and Controlled Substances</u> is up for review as part of the regular review process. No changes are being recommended.
 - A consensus was reached by the Governance Committee to accept the FIRST READING of BP-3233, Alcoholic Beverages and Controlled Substances.
- 5. A consensus was reached by the Governance Committee to accept the FIRST READING for deletion of BP-6162, <u>Professional Travel</u>. This policy has been replaced by BP-6164, <u>Reimbursement of Travel and Other Business Related Expenses</u>.

- 6. BP-7011, <u>Harassment/Sexual Harassment</u>, is up for review as part of the regular review schedule. No revisions are being recommended.
 - A consensus was reached by the Governance Committee to accept the FIRST READING of BP-7011, Harassment/Sexual Harassment.
- 7. Dr. Michael Chipps reported that, following discussion with Dr. Terry Nelson, he worked with the Association of Community College Trustees (ACCT) to bring a consultant to campus to facilitate a day-long professional development opportunity for the Board of Governors.
