## **MINUTES**

- 1. Dirk Petersen, Chairperson of the Governance Committee, convened the meeting at 1:52 p.m. in Suite G of the Lifelong Learning Center.
- 2. Recommended approval of the Minutes of the June 13, 2019 meeting as presented.
- 3. Revisions to BP-7502, <u>Eligibility Standard for Employee Insurance and Retirement Benefits</u> includes minor clean up of language. Following a brief discussion, a consensus was reached by the Governance Committee to recommend to the Board of Governors to accept the SECOND READING and to recommend approval of revisions to BP-7502, <u>Eligibility Standard for Employee Insurance and Retirement Benefits</u>.
- 4. A consensus was reached by the Governance Committee to recommend to the Board of Governors to accept the SECOND READING and recommend approval of revisions to BP-7520, <u>Life Insurance</u>. Revisions include minor clean up of language.
- 5. Following a brief discussion, a consensus was reached by the Governance Committee to recommend to the Board of Governors to accept the SECOND READING and recommend approval of revisions to BP-7540, <u>Workers' Compensation</u>. Revisions to the policy include incorporating workers' compensation law into the document.

- approval of revisions to BP-7560, <u>Retirement Benefits</u>. Revisions include removing TIAA language and replacing it with retirement plan.
- 7. A consensus was reached by the Governance Committee to recommend to the Board of Governors to accept the SECOND READING and recommend approval of revisions to BP-7610, College Holidays. Revisions include language to make it more consistent and removing 'due to inclement weather and other reasons' from Section 3.2.
- 8. An update regarding the presidential search process was provided. Board members who serve as part of the search committee are encouraged to begin reviewing applications.
